MINUTES – WAYLAND SCHOOL COMMITTEE Special Meeting – April 7, 2016 – Session #2

A Special Meeting of the Wayland School Committee was held on Thursday, April 7, 2016 at 7:00 P.M. in Room A149 at Wayland High School.

Ellen Greico convened the special session as noted in the meeting notice for 7:00 p.m. this evening.

1. Financial Matters:

(a) <u>Continued Discussion and Possible Vote to Approve FY17 Special Revenue Fund Budgets and Associated Fees/Tuitions:</u>

As prepared by Susan Bottan, the School Committee reviewed the FY17 special revenue fund budgets and the associated fees and tuitions for BASE, Pegasus, The Children's Way, Enrichment, and Tutoring in preparation for the Committee's approval. Changes to the fees were approved by the School Committee at a previous meeting.

Upon a motion duly made by Barb Fletcher, seconded by Ellen Grieco, the School Committee <u>voted</u> (4-1) to approve the FY17 budgets for the Special Revenue Funds as presented tonight. (Donna opposed based on the use of surplus funds).

Upon a motion duly made by Barb Fletcher, seconded by Kathie Steinberg, the School Committee <u>voted</u> unanimously (5-0) to approve the FY17 fees and tuitions as presented tonight, except for WHS hockey, WHS crew, WHS sailing, and full day kindergarten.

A discussion ensued about separating the hockey, sailing, and crew fees from this vote. Full day kindergarten tuition was approved at a previous meeting.

(b) Vote to Approve Invoices from Pinck & Co., BidDocs Online, Inc., and Lockheed Window Corp. related to the Claypit Hill Windows Repair Project/MSBA Accelerated Repair Program:

Jeanne confirmed that the Permanent Municipal Building Committee approved these invoices at its last meeting.

Upon a motion duly made by Barb Fletcher, seconded by Kathie Steinbergt, the School Committee <u>voted</u> unanimously (5-0) to approve the invoices from Pinck & Co., BidDocs Online, Inc., and Lockheed Window Corp related to the Claypit Hill Windows and Doors Repair Project, which is the MSBA accelerated repair program as presented tonight.

2. Administrative/Procedural Matters:

- (a) <u>Further Discussion of School Committee Comments on Budget for Town Meeting:</u>
 The Committee did not have a discussion on this matter.
- (b) <u>Discussion of Open Meeting Law and Public Record Matters, including Letters received from the Supervisor of Public Records on March 28, 2016 and March 24, 2016, and Discussion with AAG Hanne Rush regarding her Letter of March 15, 2016:</u>

Ellen updated the School Committee regarding her conversation with Hanne Rush related to Ms. Rush's letter of March 15, 2016 in which the Committee is required to participate in Open Meeting Law training. Ms. Rush agreed to allow the School Committee to watch the May 20, 2015 training tape given by the law firm of Kopelman & Paige. Ms. Rush noted a 30-day time frame in which the School Committee must review the training tape; however, Ellen was confident that an extension would be approved. Mark Lanza will also be present to answer any questions from the School Committee.
